I urge you to allow John Jeannette to change her legal gender, including the gender markers on her official documents issued by the state, through a timely, accessible, and transparent procedure.

I call on you to introduce the following reforms:

- Introduce a legislative proposal that sets out a framework allowing transgender people to obtain legal recognition of their gender through a timely, accessible, and transparent procedure and in accordance with the individual's sense of gender identity;
- Abolish the sterilization requirement as well as any other medical requirement currently enforced in instances where transgender people seek legal gender recognition;
- Remove gender identity from the classification of mental diseases and reclassify aspects relevant to the provision of health care in a non-stigmatizing health category;
- Ensure that transgender people can access the health treatments they wish on the basis of their informed consent;

I am writing to you regarding the attacks against Paraskevi Kokoni.

I urge you to ensure that those responsible for the attack against Paraskevi Kokoni are convicted and the hate crime is duly taken into account in sentencing: Any conviction of the perpetrators should also take into account the anti-Roma atmosphere in Paraskevi Kokoni's home town Etoliko, as demonstrated by the attacks against the Roma community in August 2012 and January 2013.

I call on you to undertake the necessary review of Greece's legislation in order for the police to be obliged to pursue a line of enquiry about the possible hate motive behind attacks similar to Paraskevi Kokoni's case.

I urge you that all crimes perpetrated with a discriminatory motive, including racially motivated crimes, are fully and effectively investigated, including by taking all steps to highlight the discriminatory motive behind the crime. I call on you to those against whom sufficient admissible evidence exists should be prosecuted under laws providing for sanctions that reflect the gravity of the human rights abuses.

I am concerned that Private Chelsea Manning was sentenced to 35 years in prison. Some of the information leaked by Chelsea Manning was of great value to the public debate since it pointed to potential human rights violations and breaches of international humanitarian law by US troops, by Iraqi and Afghan forces operating alongside US forces, by military contractors and by the CIA.

I am concerned that at her trial, Chelsea Manning was not allowed to present evidence that she was acting in the public interest, and was only allowed to explain her motives at the sentencing phase. Given Chelsea Manning's motivation for acting as she did, the treatment she endured in early pre-trial detention, and the due process shortcomings during her trial, I respectfully urge you to commute her sentence to the time she served in pre-trial detention, and immediately release her.

I urge the US government to urgently investigate the potential human rights violations exposed by Chelsea Manning.

I urge the US government to strengthen protections for those who reveal information that the public has the right to know, and to stop using the Espionage Act to prosecute whistleblowers like Chelsea Manning.
